Code Enforcement

Colin has recently attended training conference. He is doing and excellent job. He is currently working on several structures.

Last month the Board spoke to Mr. King on his plan to address concerns in regards to his properties. Mr. King has sent a tractor trailer out and is awaiting another truck and a dumpster to come back to fill. It has been maybe a month since the last dumpster was sent away. April 20 is the next Town Board meeting and it is expected that another dumpster be in place and a commitment has been made to continue with the removal of debris. Mr. King must comply with the court order. The Code Officer will be in charge and report back to the Board. If work has not been completed by May 1st bids will go out. The Code Officer will have direct control. Board wants to see real progress they have worked with Mr. King for 5 years and progress has been shown. The Code Enforcement Officer will make an appointment with Mr. King for reviewing the situation.

Animal Control

Animal Control and Essex County Sheriff Department have been involved with a neglected animal resulting in death. All remaining animals have been removed and tickets have been issued. Animal Control Officer has been very diligent in his job.

Parks

Ads have been published in the Sun Community News regarding the position of Manager for Monitor Bay Park. Resumes are to be in the Town Clerk's Office by March 30. The committee for Parks Kevin Gadway and John Wayman will review resumes and conduct interviews then come back to the Board with their suggestions. The position will be filled by one person this year. One campsite will be available for short term campers. A written list of expectations for manager will be provided.
